

The Eufaula City Board of Education met in regular session Tuesday, July 20, 2021, in the board room at Central Office. Members present were: Mrs. Twana R. Purifoy Anderson, Mrs. Caty H. Richardson, and Mr. Richard W. Wingate. Visitors present (not all inclusive): Joey Brannan, Susan Webb, James Bailey, Zane Johnson, Alicia Lyles, Pastor Hunter, Tinnie Hunter, Laura Stewart, Emily Jackson, Tina Richards, Brandon Kiser, Jan Bowen, Roshanda Lewis, Holly Mitchell, Melissa Larson, Deltonya Warren, Rusti Register, and Wes Register.

The notice of this meeting was posted on the public bulletin board in the central office on June 24, 2021. A reminder was sent electronically on June 24, and July 16, 2021 to a list of people who request board meeting information.

1. Mr. Richard W. Wingate called the meeting to order at 5:39 p.m. A quorum was established with three members present. Mrs. Caty H. Richardson moved for the board to approve the agenda as presented, and Mrs. Twana R. Purifoy Anderson seconded the motion. Motion was approved with a unanimous vote. Voting was as follows: “AYE” – Anderson, Richardson, and Wingate. “NAY” – None.
2. Delegations/Awards: There were no delegates to address the board.
3. Mr. Richard W. Wingate called for the approval of the minutes from the June 15, 2021, and July 9, 2021 board meetings. Mrs. Caty H. Richardson moved that the minutes be approved and Mrs. Twana R. Purifoy Anderson seconded the motion. Motion was approved with a unanimous vote. Voting was as follows: “AYE” – Anderson, Richardson, and Wingate. “NAY” – None.
4. Superintendent’s Report: The Superintendent shared Eufaula High School yearbooks from 1952 until the present are available online at the Eufaula Carnegie Library’s website. He explained that the school nurses are waiting on a toolkit of information from ALSDE and ADPH. The board received the July 2021 report from ALVA.
5. Financial Statements and Bank Reconciliations: The May 2021 financial report for the system was reviewed and discussed. 68.18% of revenues have been collected, and 57.75% of the budget has been expended. The financial statement presented included all reconciled bank accounts for the Eufaula City Board of Education as of May 31, 2021. The Board was notified of this from Chief Financial Officer by statement noted on the Financial Report.

6. New Business:

- A. Audit Report: Don Hartzog reviewed the audit report. The Superintendent recommended the board accept the audit report as presented. Mrs. Caty H. Richardson moved to accept the recommendation as presented and Mrs. Twana R. Purifoy Anderson seconded the motion. Motion was approved with a unanimous vote. Voting was as follows: “AYE” – Anderson, Richardson, and Wingate. “NAY” – None.
- B. NWEA Professional Learning: The Superintendent recommended the board approve a contract with NWEA Professional Learning for a testing system for grades Kindergarten through Eighth Grades in the amount of \$17,500. Mrs. Caty H. Richardson moved to accept the recommendation as presented. Mrs. Twana R. Purifoy Anderson seconded the motion. Motion passed with a unanimous vote. Voting was as follows: “AYE” – Anderson, Richardson, and Wingate. “NAY” – None.
- C. K-2 Grading Revision: The Superintendent recommended the board approve moving from a grading scale of 1-4 to a traditional 10 point grading scale. Grades will be entered into PowerSchool and printed in the same way as grades 3-12. Mrs. Twana R. Purifoy Anderson moved to accept the recommendation as presented. Mrs. Caty H. Richardson seconded the motion. Motion passed with a unanimous vote. Voting was as follows: “AYE” – Anderson, Richardson, and Wingate. “NAY” – None.
- D. 2021-2022 Salary Schedule Addendum: The Superintendent recommended the board approve changes to the salary schedule. Changes include adding a second assistant band supplement. Mrs. Caty H. Richardson moved to accept the recommendation as presented. Mrs. Twana R. Purifoy Anderson seconded the motion. Motion passed with a unanimous vote. Voting was as follows: “AYE” – Anderson, Richardson, and Wingate. “NAY” – None.
- E. 2021-2022 Organization Chart: The Superintendent recommended the board approve the 2021-2022 Organization Chart. Mrs. Twana R. Purifoy Anderson moved to accept the recommendation as presented. Mrs. Caty H. Richardson seconded the motion. Motion passed with a unanimous vote. Voting was as follows: “AYE” – Anderson, Richardson, and Wingate. “NAY” – None.
- F. Positions Needed for 2021-2022: Deltonya Warren explained the need for a secondary level EL Coach; two virtual instruction facilitators and an additional primary school physical education teacher. The Superintendent recommended the board approve the needed positions as presented. Mrs. Twana R. Purifoy Anderson moved to accept the recommendation as presented. Mrs. Caty H. Richardson seconded the motion. Motion passed with a unanimous vote. Voting was as follows: “AYE” – Anderson, Richardson, and Wingate. “NAY” – None.

- G. ARCH Counseling, LLC: Jan Bowen informed the board that ARCH counseling would replace the need for SpectraCare and provide school based mental health services to all students. There is a \$50,000 yearly cap for district expense. Mrs. Katy H. Richardson moved to accept the recommendation as presented. Mrs. Twana R. Purifoy Anderson seconded the motion. Motion passed with a unanimous vote. Voting was as follows: “AYE” – Anderson, Richardson, and Wingate. “NAY” – None.
- H. Student Activities: The Superintendent recommended the board approve student activities and fundraisers for Eufaula High School, and Admiral Moorer Middle School. Mrs. Twana R. Purifoy Anderson moved to accept the recommendation as presented and Mrs. Katy H. Richardson seconded the motion. Motion passed with a unanimous vote. Voting was as follows: "AYE" - Anderson, Richardson, and Wingate. “NAY” – None.
